FOREWORD

Criminology tends to be viewed as a lowbrow discipline by folk from other social sciences. Perhaps that is because intellectual standards were once lower in criminology than those of the best criminology today. Perhaps it is also because other social scientists see criminology as a populist field. Naturally, they notice those criminologists who appear on television to speculate on what might be motivating a serial murderer who has not been apprehended, whom the commentator has never met!

Perhaps the negativity is because so many of the social sciences are in decline in the west while criminology flourishes. Some of the most powerful disciplines that dominate prestigious learned academies have seen a drop in their share of student enrolments and therefore in their faculty. My more controversial view is that most social sciences are neither as interesting nor as vibrant as they were in the middle decades of the twentieth century. In contrast, fields such as biology and information technology experienced remarkable intellectual growth in this period by reorganizing their intellectual communities around newer ideas like networked cyberspace, the new molecular biology and by revisiting older notions of evolutionary biology and ecology.

We also see a certain disdain from the continuing, if waning, domination of continental criminology by the discipline of law. Some continental lawyers imagine they study solid, complex stuff with a technically demanding logical core; to these lawyers, their criminologist colleagues seem barely playing at being scholars. They would prefer the intellectual company of a philosopher or even an economist to a criminologist.

I have always been a doubter and dissenter from the disciplinary organization of the social sciences, never a hardcore member of any discipline, including criminology. This commitment to interdisciplinarity means I spend more of my time attending conferences organized by non-criminologists than by criminologists. From this comparative vantage point, and from the perspective of being decidedly not a 'true believer' in criminology as a project to discipline young minds, I am nevertheless inclined to conjecture that criminology deserves its success. And the plural debate in this volume confirms that inclination.

First, consider the populist tag. While some students enrol in criminology because they would like to learn to be a ' profiler' of a kind they have seen in Hollywood crime dramas, they actually learn more important things about crime when they arrive in the class. One might predict our disappointed profilers would drop out after the first

year. But the meat of the subject seems to sustain them more than the ephemera that attracted them to enrol.

That meat is still a seductively social kind of scholarship. Despite being drawn to other subjects I enjoy the company of criminologists more than colleagues from those other intellectual communities. Police officers are also wonderful company, interesting people, as are the occupants of prisons, on both sides of the bars. Corporate criminals are gripping conversationalists! A strength of the criminological ethos is that it is engaged with narratives of such lives that cross boundaries. As Alison Liebling puts it, good criminology tends to engage with such people 'appreciatively', taking all accounts seriously, and striving to comprehend their passions, insights and disappointments with life. So, while our aspiring young profiler might arrive thinking what will motivate her is the forensic search for clues from a cadaver, what actually does engage her is a more basic appeal that criminology shares with fiction—narratives of lives that transgress.

Undergraduates also find that criminology is a more human subject than psychology. Rats drove much of the narrative from psychology classes that many of us experienced. Criminology had serious psychology in it, substantively and methodologically, yet it also had the ethnography that so appealed in anthropology classes. And it engendered C Wright Mills's sociological imagination. Ironically, at least for me, it accomplished this better than my sociology classes. A few years later, I came to relish reading the sociological classics. But as an undergraduate, I could cotton onto the idea of a sociological imagination, of seeing institutional and macro-historical explanations for social change, seeing the personal as political, via the more concrete engagement with the crime problem, especially the study of corporate crime and gendered crime. This raises one of the interesting debates in this book: whether in the teaching of criminology what we do is engage students with the contested politics and methods of crime policy more than induct them into a discipline. I think we do, and this is the better part of what we do.

The contributions to this collection illustrate why so many undergraduates find criminology engaging in the development of their personal intellectual biographies. The chapters discuss the narrative, the social structural and the quantitatively rigorous faces of criminology. They also consider the interface between explanatory theory and normative theory that is a strength of much criminology. How could one study something like deterrence only technocratically? If it turned out empirically that boiling criminals in oil in the town square deters crime, we would still feel compelled to ask if this would be right. Integrating explanatory and normative theory tends to improve both (Pettit and Braithwaite 2000).

This book suggests that criminology take debates about social justice seriously. This message resonates elsewhere too; law schools might better engage and serve their students were normative debates, that contest what justice should mean, placed at the centre of learning—procedural justice, formal justice, punitive justice, restorative justice, social justice.

Criminology has its share of intellectual factionalism and epistemological dogmatism, though less than it used to. Yet, overall, a key strength of criminology, compared with most of the social sciences, is that epistemological pluralism is the dominant ethos. If you share my belief that the social sciences have dug themselves into a terrible set of holes, pluralistic openness to diverse tools, and new tools, will be needed to dig toward the light.

A final reason criminology has deserved its comparative success is that it offers material that policy-makers can use. 'Nothing works' nihilism used to be common. Recent decades have seen not only quality research on why institutions like imprisonment can be so counterproductive, but has also identified better investments that can reduce crime, and sometimes increase social justice and victim justice at the same time. These fruits have made criminology more successful than many other social sciences in attracting funding from foundations and the public purse.

Even so, more work needs to be done as politicians and the public do not always wish to believe criminological evidence. My own suspicion is that the social movement for restorative justice, conceived as a long-run agenda of social justice transformation starting with conflict resolution in schools, could educate future generations to be more thoughtful and less automatically punitive in their thinking about how to respond to violence and theft. We are not born democratic and decent; civility is something we must learn in a structured way.

In the early and mid-1990s some of us spent more than a few years avoiding criminology conferences; it seemed more strategic to build evidence-based restorative justice in hybrid researcher-practitioner communities outside the walls of the academy. By the late 1990s, however, criminology had become extremely welcoming to those restorative justice debates that it had previously viewed as marginal. These debates were productively incorporated within criminology's broad church. Again, we might see that kind of history as evidence of a field that is now mature in its openness.

For all those virtues, criminology remains far too Anglophone an intellectual tradition. It also has too weak a comparative imagination, though the rise of higher quality crime research in Asia and at Europe's margins feeds hope, as does work in the south with a postcolonial and a transnational sensibility that has been ably embraced into this volume. Marcus Felson is surely right in his chapter when he says criminology 'does best when considering crime as a very local matter'; yet it is impoverished by the limited set of localities it learns from. An American mentor once described the pages of *Criminology* as applying progressively greater rigour to ever more trivial questions. Little wonder Jeff Ferrell in his chapter 'drifts' away from such journals—akin to the way a delinquent drifts from the discipline of dominant normative orders. Our undergraduate classes are more intellectually engaging than most of the work published in our journals. Still we all learn how to find those pieces of wheat among criminology's piles of chaff. And the contributions to this volume will help us think critically about how to sift.

As I write, I am preparing papers for the 2010 International Peace Research Association conference, and feel glad to be a peace researcher rather than a Peaceologist. I would prefer students to study research methods of general use in the social sciences that can also be applied to crime and theory about particular kinds of crime and particular kinds of institutions. So it surprises me how very useful criminological theory so often proves in the study of peacebuilding.

The editors have done a splendid job of setting up the conversation in this volume, both at the conference in Oxford and in their introductory chapter, and have brought together a stellar collection of contributors. I understand those who the editors say declined the invitation to contribute. There is some virtue in getting on with the job of doing whatever one is best at without devoting large swathes of professional time to navel gazing. Then again, a certain amount of this can be healthy if your navel is worth a look, and I can promise readers some high quality, insightful, gazing here. More than that, we can learn quite a bit from this book about how to retool criminology worksites to be more productive, sharper in their insights, more fun and more just.

Kathleen Daly is Professor of Criminology and Criminal Justice, Griffith University (Brisbane, Australia). She writes on gender, race, crime, and justice; and on restorative, Indigenous, and international criminal justice. First based in the United States 1983–95 (Yale University and the University of Michigan), she travelled to Australia in 1995 as a Senior Fulbright Scholar to study restorative justice. From 1998 to 2006, she received three Australian Research Council (ARC) grants to research restorative justice and the race and gender politics of alternative justice practices. In 2008, she launched an international project on innovative responses to sexual violence, also funded by the ARC; and in 2009, as co-CI, she is participating in a fifth ARC-funded

project on legal responses to Indigenous partner violence. In addition to books and edited collections, she has published over seventy articles in journals, edited volumes, and law reviews. She is a Fellow of the Academy of the Social Sciences in Australia, and immediate past President of the Australian and New Zealand Society of Criminology (2005–9).

Aaron Doyle is Associate Professor of Sociology at Carleton University in Ottawa, Canada. His research interests include risk, insurance, and security; experiences of risk in everyday life; criminological theory; crime and media; and visual surveillance. David Garland is Arthur T. Vanderbilt Professor of Law and Professor of Sociology at New York University. He has taught at the University of Edinburgh and held visiting positions at Leuven University, UC Berkeley, and Princeton University. He received his AB in 1973 from the University of California, Davis and PhD in 1976 from SUNY at Albany. He is the author or editor (with others) of several books, including: *Control Theories of Crime and Delinquency* (2003); *Personal Liberty and Community Safety* (1995); *The Generality of Deviance* (1994); *A General Theory of Crime* (1990); *Decision-making in Criminal Justice* (1988); *Positive Criminology* (1987); *Policy Guidelines for Bail: An Experiment in Court Reform* (1985); *Understanding Crime* (1980); and *Victims of Personal Crime* (1978). He has published numerous articles in journals, including *Criminology*, *American Journal of Sociology*, *American Sociological Review*, *Advances in Criminological Theory*, and various law reviews. He is a Fellow of the American Society of Criminology, the recipient of the Paul Tappan Award by the Western Society of Criminology for outstanding contributions to the field of criminology, the Distinguished Graduate Award from the Nelson Rockefeller College of Public Affairs and Policy, and the Richard McGee Award for 'Outstanding Contributions to Crime Theory' from the American Justice Institute.

Kevin D. Haggerty is editor of the *Canadian Journal of Sociology* and book review editor of the international journal *Surveillance and Society*. He is professor of sociology and criminology at the University of Alberta and a member of the executive team for the *New Transparency* Major Collaborative Research Initiative. Surveillance and Visibility (University of Toronto Press); and *Surveillance & Democracy* (Routledge).

Kelly Hannah-Moffat is a professor and Chair of the Department of Sociology at University of Toronto Mississauga, where she has been since 1999. She is cross-appointed to the Centre of Criminology and is a Massey College Senior Fellow. She has published numerous articles and books on risk, punishment, parole decision making, gender and diversity. She recently published *Gendered Risks* (with Pat O'Malley, Routledge Cavendish, 2007); 'Restructuring Pre-sentence Reports Race, Risk, and the PSR' *Punishment and Society*, (2010), 12(3) with Paula Maurutto; and 'Under These Conditions: Gender, Parole, and the Governance of Reintegration' *British Journal of Criminology*, (2009), 49:1-20 (with Sarah Turnbull).

Ole Kristian Hjemdal became a sociologist in 1975. From 1981 to 1988 he worked together with Thomas Mathiesen at the Institute of Sociology of Law at the University of Oslo, as a researcher and assistant professor. From 1988 until 1995 he was an associate professor at Oslo University College and then headed the Norwegian Centre for Information and Studies of Violence from 1996 until 2003. In 2004 the Centre became a part of The Norwegian Centre for Violence and Traumatic Stress Studies, where he now heads the section for studies on violence and trauma-adults. His research is on ethnic discrimination and integration of immigrants and ethnic minorities; social work; self-help organization and on interpersonal violence. His latest work has been on violence against pregnant women and on men as victims of family violence.

Tim Hope is Professor in Criminology, University of Salford, Greater Manchester. Between 1974 and 1991 he worked at the Home Office Research and Planning Unit, where he earned a PhD in Sociology from the University of London. He has also held positions with CACI Ltd. and the Universities of Keele, Missouri-St. Louis and Manchester. He has been a visiting research fellow of the Scottish Centre for Crime and Justice Research (University of Edinburgh), the Quantitative Criminology Group of the Cathie Marsh Centre for Census and Survey Research (University of Manchester), and the Vauxhall Centre for Criminology (University of Luton). He was Director of the Economic and Social Research Council Crime and Social Order Research Programme and the Keele Community Safety Group. He is, or has been, an adviser or consultant to the International Centre for the Prevention of Crime, the European Forum for Urban Safety, the Audit Commission for England and Wales, the UK Statistics Commission (on crime statistics), the National Reassurance Policing Programme, the City of St Louis, MO. Police Department, and the Safer Bury Partnership. He is a member of GERN, jointly coordinated (with Dario Melossi) the work-package 'local public policies of crime prevention' of the CRIMPREV Co-ordination Action of the European Union Sixth Framework Programme, and was an expert consultant to the European Commission evaluation

of the European Crime Prevention Network. On the politics of crime control evaluation, he has given oral and written evidence to the House of Commons Science and Technology Committee, contributed to the CRIMPREV Methodology and Good Practice work-package, and published *Critical Thinking about the Uses of Research* (with Reece Walters). He has presented and published papers (some in translation) in the United States, Canada, France, Germany, Italy, Netherlands, Czech Republic, Poland, and Portugal.

Mike Hough is Director of the Institute for Criminal Policy Research in the School of Law at King's College London. Mike has published extensively on a range of criminological topics including policing, crime prevention and community safety, anti-social behaviour, probation and drugs. Current work includes research on sentencing, on drugs, on youth justice and on public trust in justice. He is the President of the British Society of Criminology. His recent publications include: 'Crime and Criminal Justice: Exploring the Policy Options' (with Julian Roberts in *Option for a New Britain*, edited by Varun Uberoi, Adam Coutts, Iain McClean and David Halpern, Palgrave MacMillan, 2009); *Tackling Prison Overcrowding* (edited with Rob Allen and Enver Solomon, Policy Press, 2008); and *Surveying Crime in the 21st Century* (edited with Mike Maxfield, Willan, 2007).

Alison Liebling is Professor of Criminology and Criminal Justice and Director of the Prisons Research Centre at the University of Cambridge Institute of Criminology. She has carried out research on suicides in prison, staff-prisoner relationships, the work of prison officers, small units for difficult prisoners, incentives and earned privileges, prison privatization, values and practices in prison life, and measuring the quality of prison life. She has published several books, including *Suicides in Prison* (1992), *Prisons and their Moral Performance* (2004) and (with Shadd Maurna) (2005) *The Effects of Imprisonment*.

Ian Loader is Professor of Criminology and Director of the Centre for Criminology at the University of Oxford, United Kingdom. He is author of *Civilizing Security* (with Neil Walker, 2007, Cambridge University Press) and *Public Criminology?* (with Richard Sparks, 2010, Routledge) and is currently engaged in research and writing on markets for security.

Monique Marks is based in the Community Development Programme at the University of KwaZulu-Natal. She is also a Research Associate of the Centre of Criminology at the University of Cape Town. She has published widely in the areas of youth social movements, ethnographic research methods, police labour relations, police organizational change and security governance. She has published three books: *Young Warriors: Youth Identity, Politics and Violence in South Africa*; *Transforming the Robocops: Changing Police in South Africa*; and *Police Occupational Culture: New Debates and Directions* (edited with Anne-Marie Singh and Megan O'Neill).

Shadd Maruna is Director of the Institute of Criminology and Criminal Justice at the School of Law Queen's University Belfast where he is also Professor of Justice Studies and Human Development. He received his PhD from Northwestern University. Previously, he has been a lecturer at the University of Cambridge and the University at Albany, SUNY. His book *Making Good: How Ex-Convicts Reform and Rebuild Their Lives* (American Psychological Association, 2001) was named the 'Outstanding Contribution to Criminology' by the American Society of Criminology in 2001. His other books include: *Rehabilitation: Beyond the Risk Paradigm* (Routledge, 2007); *The Effects of Imprisonment* (Cambridge University Press, 2005); *After Crime and Punishment: Pathways to Ex-Offender Reintegration* (Willan, 2004); and *Fifty Key Thinkers in Criminology* (2010, Routledge).

Thomas Mathiesen completed his PhD at the University of Oslo on a prison study in 1965 (*The Defences of the Weak*, Tavistock Publications). He became Professor of Sociology of Law in 1971 and, after retirement in 2003, Professor Emeritus. He is still active at the Department of Criminology and Sociology of Law at Oslo and is author of a number of books on sociology of law, criminology, media power and the silencing power of public administration. A number of his books and articles are published in a wide range of languages. Six of his books are published in English, including: *The Politics of Abolition* (1974) and *Prison on trial* (3rd edn. 2006). He is co-founder, and active member of KROM—The Norwegian Association of Penal Reform, which commenced its activities in 1968. KROM is a pressure group in the field of penal policy, and has inmates, ex-inmates and non-inmates on the board and among its members. Many of Mathiesen's publications are based on his wide experience as a member of this group.

Eugene McLaughlin is Professor of Criminology and Sociology in the Department of Sociology, City University London. He is currently co-director of the *Law, Justice and Journalism Research Centre*. He has written extensively on police governance and reform, police–community relations, the managerialization of criminal justice and contemporary criminological theory. His current research concentrates on the theory and practice of policing in multi-pluralist societies, the news media and crime, and the contemporary knowledge practices of critical criminology. His most recent books are *The Sage Handbook of Criminological Theory* (co-edited with Tim Newburn, Sage, 2010) and *The New Policing* (Sage, 2007). He is also the co-editor of *Public Criminologies* (Special Issue of *Theoretical Criminology*, edited with Lynn Chancer, 2007); *The Sage Dictionary of Criminology* (edited with John Muncie, Sage, 2005) and *Criminological Perspectives: Essential Readings* (edited with Gordon Hughes and John Muncie, Sage, 2002). He is a member of the editorial boards of the *British Journal of Criminology*, *Crime, Media and Culture* and *Theoretical Criminology*.

Linda G. Mills is Professor of Social Work, Public Policy, and Law at New York University. She is also Executive Director of NYU's Center on Violence and Recovery,

NYU's Senior Vice Provost for Undergraduate Education and University Life and Associate Vice Chancellor for Admissions and Financial Support for NYU Abu Dhabi. In her books, *Violent Partners: A Breakthrough Plan for Ending the Cycle of Abuse* (Basic Books, 2008) and *Insult to Injury: Rethinking Our Response to Intimate Abuse* (Princeton University, 2003), Mills challenges current paradigms of domestic abuse and develops a new theory and practice based on empirical research, for rethinking how we respond to violence in intimate relationships. Mills' publications include: 'Circulos de Paz and the Promise of Peace: Restorative Justice Meets Intimate Violence' (with Mary Helen Maley and Yael Shy), *NYU Review of Law and Social Change*, 2009; 'Shame and intimate abuse: The critical missing link between cause and cure', *Children and Youth Services Review*, 2008; 'The justice of recovery: How the state can heal the violence of crime', *Hastings Law Journal* in 2006; 'Fighting for child custody when domestic violence is at issue: A survey of state laws and a call for more research' (with Amy Levin), *Social Work*, 2003; 'The law of white spaces: Race, culture, and legal education' (with Peter Goodrich), *Journal of Legal Education*, 2001; and 'Killing Her Softly: Intimate Abuse and the Violence of State Intervention', *Harvard Law Review*, 1999. Mills is currently directing and producing a documentary called 'Auf Wiedersehen: 'Til We Meet Again', a film that explores the intergenerational transmission of trauma from the Holocaust to 9/11. The film has been invited to several film festivals and recently won an Audience Award, Runner Up for Best Documentary, at the Los Angeles Jewish Film Festival.

David Nelken taught criminology at Cambridge University, Edinburgh University and University College, London before moving to Italy. He is currently Distinguished Professor of Sociology at the University of Macerata, Italy, as well as Distinguished Research Professor of Law at Cardiff University, and Visiting Professor of Law at the London School of Economics. He has been appointed visiting professor of Criminology at the Oxford Centre of Criminology from 2010–13. He is an Academician of the UK Academy of Social Sciences and received a Distinguished Scholar Award from the American Sociological Association in 1985 and the Sellin-Glueck Award from the American Society of Criminology in 2009. His research focuses on white-collar crime, corruption, and comparative criminology. His most recent book is *Comparative Criminal Justice: Making Sense of Difference* (Sage, 2010).

Tim Newburn is Professor of Criminology and Social Policy at the London School of Economics. He is a past President of the British Society of Criminology and author/editor of over thirty books including: *Sage Handbook of Criminological Theory* (ed with McLaughlin, Sage, 2010); *Key Readings in Criminology* (Cullompton: Willan, 2009); *Policing Developing Democracies* (edited with Hinton, London/New York: Routledge, 2008); *Policy Transfer and Criminal Justice* (with Jones, Open University Press, 2007); *Criminology* (Cullompton: Willan, 2007); and *The Politics of Crime Control* (ed with Rock, Clarendon Press, 2006).

Ian O'Donnell is Professor of Criminology at University College Dublin and an Adjunct Fellow of Linacre College, Oxford. Previously he was director of the Irish Penal Reform Trust. His most recent book is *Child Pornography: Crime Computers and Society* (with Claire Milner, Willan, 2007).

Stephan Parmentier studied law, political sciences and sociology at the KU Leuven (Belgium) and the University of Minnesota-Twin Cities (United States). He currently teaches sociology of crime, law, and human rights at the Faculty of Law of the KU Leuven, where he has served as the Director of the Law and Society Institute and the Head of the Department of Criminal Law and Criminology. He has been a visiting professor at the International Institute for Sociology of Law in Oñati (Spain), the University for Peace (San José, Costa Rica) and the University of New South Wales (Sydney, Australia), and a visiting scholar at the universities of Stellenbosch (South Africa), Oxford (United Kingdom) and New South Wales (Sydney, Australia). He was the editor-in-chief of the *Flemish Yearbook on Human Rights* and is the founding general co-editor of the new book *Series on Transitional Justice* (Intersentia Publishers, Antwerp). Parmentier has also served as an advisor to the European Committee for the Prevention of Torture, the Belgian minister of the Interior, the King Baudouin Foundation, and Amnesty International. His research interests include political crimes, transitional justice and human rights, and the administration of criminal justice. He was the vice-president of the Flemish section of Amnesty International between 1999 and 2002.

Ray Paternoster is Professor in the Department of Criminology and Criminal Justice at the University of Maryland, United States. His research interests include the analysis of offender decision-making, behavioural economics and crime, issues pertaining to capital punishment, criminological theory, desistance from crime, and the transition from adolescence to adulthood. He received his PhD degree from Florida State University in 1978 and has been at the University of Maryland since 1982.

Nicole Rafter teaches in the College of Criminal Justice, Northeastern University, United States. Her research interests include criminological theory, crime films, the history of criminology, and the work of Cesare Lombroso. Her most recent books include: *Origins of Criminology: A Reader* (Routledge, 2009); *The Criminal Brain: Understanding Biological Theories of Crime* (New York University Press, 2008); *Shots in the Mirror: Crime Films and Society* (Oxford University Press, 2006); and a new translation of Lombroso's *Criminal Man* (with Mary Gibson, Duke University Press, 2006). With Michelle Brown, she is currently working on *Criminology Goes to the Movies*, a book examining intersections among films and criminological theories (forthcoming, 2011). She is a Fellow of the American Society of Criminology and winner of its 2009 Sutherland Award.

Beth E. Richie is The Director of the Institute for Research on Race and Public Policy and Professor of African American Studies and Criminology, Law and Justice at The

University of Illinois at Chicago. The emphasis of her scholarly and activist work has been on the ways that race/ethnicity and social position affect women's experience of violence and incarceration, focusing on the experiences of African American battered women and sexual assault survivors. Dr Richie is the author of numerous articles concerning Black Feminism and Gender Violence, Race and Criminal Justice Policy, and 'The Social Dynamics around issues of sexuality, families and grassroots organizations in African American Communities. Her book *Compelled to Crime: the Gender Entrapment of Black Battered Women* is cited in the popular press for its original arguments concerning race, gender and crime. Her upcoming book, *Black Women, Male Violence and the Build-up of a Prison Nation* chronicles the evolution of the contemporary anti-violence movement during the time of mass incarceration in the United States. Her work has been supported by grants from The Robert Wood Johnson Foundation, The Ford Foundation, and The National Institute for Justice and The National Institute of Corrections. She has been awarded the Audre Lorde Legacy Award from the Union Institute, The Advocacy Award from the US Department of Health and Human Services, and The Visionary Award from the Violence Intervention Project. Dr Richie is a board member of The Woods Fund of Chicago, The Institute on Domestic Violence in the African Community, The Center for Fathers' Families and Public Policy and a founding member of INCITE!: Women of Color Against Violence.

William A. Schabas is director of the Irish Centre for Human Rights at the National University of Ireland, Galway, where he holds the Chair in Human Rights Law. He is also an Honorary Professor at the Chinese Academy of Social Sciences, in Beijing, and *Professeur Associé* at the Université du Québec à Montréal. He is the author of more than twenty books and 275 journal articles, on such subjects as the abolition of capital punishment, genocide and the international criminal tribunals. His most recent book, *The International Criminal Court: A Commentary on the Rome Statute*, was published by Oxford University Press in 2010. He is editor-in-chief of *Criminal Law Forum*. Professor Schabas was a member of the Sierra Leone Truth and Reconciliation Commission. He is the chairman of the Board of Trustees of the United Nations Voluntary Fund for Technical Cooperation in Human Rights. He is an Officer of the Order of Canada, a member of the Royal Irish Academy, and the current laureate of the Vespasian V. Pella Medal for International Criminal Justice of the Association internationale de droit penal.

Clifford Shearing is the Chair of Criminology and holds the South African Research Chair of Security and Justice in the Faculty of Law at the University of Cape Town where is his also the Director of the Centre of Criminology. His research focuses on the governance of security. His most recent books are *Imagining Security* with Jennifer Wood (Willan, 2007) and *Lengthening the Arm of the Law* with Julie Ayling and Peter Grabosky (Cambridge, 2009).

Lawrence W. Sherman is the Wolfson Professor of Criminology at the University of Cambridge, where he directs the Jerry Lee Centre of Experimental Criminology and the Police Executive Programme. He is also a Distinguished University Professor at the University of Maryland in the Department of Criminology and Criminal Justice. He has designed or directed over thirty randomized field experiments in crime prevention and justice, including twelve restorative justice experiments in Australia and the United Kingdom, as well as evaluations of policies for policing domestic violence, hot spots of crime, and gun crime. He has been elected President of the American Academy of Political and Social Science, the American and International Societies of Criminology, and the Academy of Experimental Criminology.

Natalie J. Sokoloff, Professor of Sociology, has been a member of the faculty of John Jay College of Criminal Justice for forty years. She is also a member of the doctoral faculties in Sociology, Criminology, and Women's Studies at the Graduate School, City University of New York. She teaches courses on women, crime, and justice; imprisonment and empowerment; and domestic violence. In 2005 she was doubly honoured with the Outstanding Teaching Award at John Jay College and the Distinguished Scholar Award from the American Society of Criminology's Division on Women and Crime. Some of her recent publications include 'The Intersectional Paradigm and Alternative Visions to Stopping Domestic Violence: What Poor Women, Women of Color, and Immigrant Women Are Teaching Us about Violence in the Family', *International Journal of Sociology of the Family* (American Sociological Association, 2008); 'Expanding the Intersectional Paradigm to Better Understand Domestic Violence in Immigrant Communities', *Critical Criminology* (2008); 'Locking up Hope: Immigration, Gender, and the Prison System', *Scholar and Feminist Online*, 6(3) (2008); 'Impact of the Prison Industrial Complex on African American Women', *Souls: A Critical Journal of Black Politics, Culture, and Society*, 5(4): 31-46; and two critically acclaimed books: *Domestic Violence at the Margins: Readings on Race, Class, Gender and Culture* (Rutgers University, 2005); and *The Criminal Justice System and Women: Offenders, Prisoners, Victims & Workers*, 3rd edn (McGraw-Hill, 2004). Richard Sparks is Professor of Criminology at the University of Edinburgh and Co-Director of the Scottish Centre for Crime and Justice Research (<<http://www.sccjr.ac.uk/>>). Richard's main research interests are in prisons; penal politics; public responses to crime and punishment, and criminological theory. His publications include: *Criminal Justice and Political Cultures* (with Tim Newburn (eds), Willan, 2004); *Criminology and Social Theory* (with David Garland (eds), Oxford University Press, 2000); *Crime and Social Change in Middle England* (with Evi Girling and Ian Loader, Routledge, 2000); and *Prisons and the Problem of Order* (with Tony Bottoms

and Will Hay, Oxford University Press, 1996). Richard's current work, in collaboration with Ian Loader, concerns competing accounts of relevance and influence in crime and justice research, and the place of criminology in debates on the public roles of the social sciences. Lucia Zedner is Professor of Criminal Justice, Law Faculty and Corpus Christi College, University of Oxford.
