## **Outside Fundraising**

Without receiving an increased share of the budget of the Research School of Social Sciences, the number of academic appointments in RegNet in RSSS increased from 5 in 2001 to 30 in 2004. The major factor in this was outside fundraising, much of it led by the RegNet Founders, Valerie and John Braithwaite. RegNet raised AU\$35 million in outside funds during 2001-2004, about half of it going to network partners outside RSSS. Since 2005, Braithwaite has been a Chief Investigator on 10 Australian Research Council Discovery, Fellowship or Linkage grants, participated in two ARC Research Networks and one Centre of Excellence. Many foreign grants have also been obtained such as from the US National Science Foundation.
